1. Application qualifications :

- Those who have completed of 12 years of education in the applicant's native country or in Japan.
- Applicant should be under 30 years old ※If you are over 30, the reason and your background history is needed.
- Those who have Japanese Language Proficiency Test (JLPT) level N5 or equivalent to it
- Those who are accepted by us through interview.

April Entrance :2-year course, 1-year course

July Entrance:1 year 9 month course

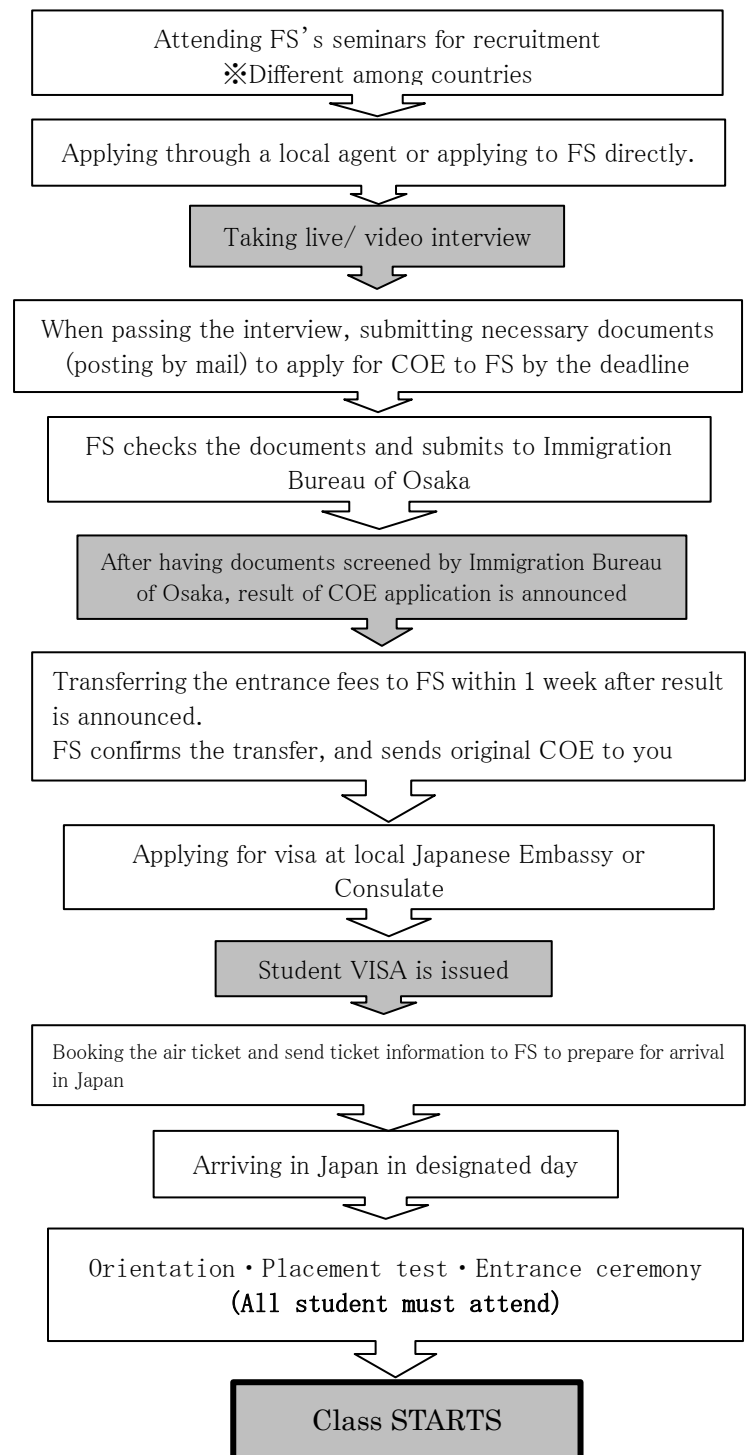
October Entrance :1.5-year course

3. Admission process (GUIDE) :

Application and Interview	9 months before ※1
Deadline for documents submission	6 months before
Deadline for application of COE to immigration	5 months before (First Half of the month)
COE result	1 and a half months before
Visa application in home country	1 month before
Arrival in Japan	School enrollment on the designated date of the month

4. Required documents for interview

① Interview Sheet	Form specified by the school
② Graduation/Passing Certificate and Marksheet of last education	Submit the Graduation/Passing Certificate and Marksheet of last education *In case of not having, Please submit a certificate of expected graduation and a transcript.

5. Application Documents

※Submit all original documents. Notarization is needed for when submitting copies.

※The applicants and sponsors documents need to be filled by themselves respectively

※All documents to be submitted to the Immigration Bureau, need to be translated

② Photocopy of passport	copy	Submit the pages with your photo and past departure from/entry into Japan. ※For those who don't yet have passport, please submit document showing that you can applied for one.
③ Resume (Application documents for admission)	original	Form specified by the school
④ Resume (Purpose of study)	original	Form specified by the school ※Specifically describe about the purpose of learning Japanese and regarding future plans after graduating from a Japanese language school
⑤ Graduation/ passing certificate of last education	original	Graduation/ passing certificate of last education ※1 ※In case of still studying, please submit a certificate of enrolment and expected graduation certificate.
⑥ Marksheet	original	Transcript of last education*1
⑦ Certificate of Japanese language proficiency	original	Proof of qualification of N5 Japanese Language Proficiency Test or equivalent test approved by the Immigration Bureau (Japanese language learning certificate for more than 150 hours) ※Information that can prove the intention to take the examination, such as the examination card or examination roll number
⑧ Certificate of employment	original	Applicants having working experience must necessarily submit.
※Education Certificate	original	Submit if applicable
※ Documents related to technical intern training	original	①Proof of technical intern training history (duration) ②Proof of skill usage for one or more year after returning to home country from Japan (certificate of employment, etc.)

⑨ Written Oath of Financial Support	original	Form specified by the school
⑩ Certificate of employment	original	For self-employed people, business registration permit and tax payment certificate (Business registration number and tax payment code should be listed)
⑪ Certificate of Income	original	Proof of income for the last 3 years
⑫ Bank Balance certificate		Fixed deposit certificate issued by the bank ※If possible, set the maturity date after the date of announcement of the result of COE.
⑬ Bank Balance statement for past 3 years.	copy	Details of deposits and withdrawals should be clear and the document should clarify the fund formation
⑭ Certification of relationship with applicant	original	Those that can prove the relationship between the applicant and the supporter like certificates, etc.
⑮ Family Constitution	copy	Proof of family structure of applicant and sponsor

※1 Please be sure to submit it as it is necessary for going on to school in Japan.

※ At the request of the Immigration Bureau of Japan, you may be asked to submit documents other than the above.

※ If any of the documents are incomplete, please correct them and submit them by the designated date.

※ If the financial sponsor is a resident of Japan, a separate document will be required, so please contact us.
